**Responses Due: December 2, 2020 – 11:00 AM, EST**

In accordance with N.J.S.A. 19:44A-20.4 et seq., the Ocean County Library is requesting qualifications (RFQ) from law firms or individuals licensed to practice law in the State of New Jersey that wish to provide general counsel and litigation services to the Library Commission for the calendar year 2021.

The successful firm(s)/individual(s) must have a primary office in Ocean County and have a minimum of five years' experience in representing a New Jersey Library and/or other public entities in contractual matters; civil service and personnel matters; public contracts; intergovernmental contracts; federal and state agreements; joint ventures; partnership and grant agreements; liability and workers compensation matters; OPRA; and general litigation.

The successful firm(s)/individual(s) will provide the Library Commission with legal guidance relating to but not necessarily limited to:

**SCOPE OF WORK- LEGAL COUNSEL SERVICES**

1. Legal research and/or advisory opinions if needed;
2. Represent the Library Commission in all matters in Federal and State courts as well as administrative tribunals and forums;
3. Review and/or draft Library Commission Resolutions, Contracts, Inter-Local and Inter-Agency agreements;
4. Must attend all monthly meetings of the Library Commission, all special meetings of the Library Commission, and all monthly meetings of the Library Foundation as requested, and provide the name of the person who will be attending;
5. Be readily available for meetings with any department heads or their designates upon request;
6. Advise the Library Commission of changes in State or Federal law or regulations, as well as court decisions, which may impact the Library Commission;
7. Any other matters as directed by the Library Commission.

**ALL SUBMISSIONS SHALL INCLUDE THE FOLLOWING MINIMUM INFORMATION**

1. Name of the individual(s) to be assigned to perform the tasks.
2. Professional experience and education of the individual(s) to be assigned, including a listing of experience with the Ocean County Library Commission and/or experience with other New Jersey Libraries and/or other public entities.
3. A statement concerning the ability of the firm(s)/individual(s) to perform tasks assigned by the Library Commission in a timely fashion.
4. Professional licenses and certifications held by the individual(s) to be assigned.
5. A description of the support staff available to the individual(s) to be assigned.
6. A list of (4) professional references with addresses and telephone contact numbers, Three (3) must have direct knowledge relating to your experience in the requested service.
7. A copy of your New Jersey Certificate of Employee Information Report Approval; pursuant to N.J.A.C.17:21-1.1 et. Seq. or a completed Form AA-302 Initial Employee Information Report.
8. A Copy of your New Jersey Business Registration Certificate should be included with the proposal. If it is not, it will be required prior to award of the contract. (See Pgs. 4 & 5 for NJBRC details)
9. Hourly Rate Schedule for Legal Counsel Services.
10. A Copy of a Certificate of Insurance, issued by an insurance carrier licensed by the State of New Jersey, for the firm(s)/individual(s) showing the amount of professional liability insurance and all other insurance coverage in place as of December 2, 2020.

**INSURANCE**

The firm(s)/individual(s) shall maintain insurance to protect against all claims under Worker's Compensation, Comprehensive General Liability and Automobile and shall be subject to approval for adequacy of protection as per the following limits:

**Primary Coverage:**

The insurance policies and coverage provided by the proposer to the Ocean County Library shall apply as primary coverage with respect to any other insurance or self-insurance program afforded to the Ocean County Library. There shall be no endorsement or modification of this coverage to make it excess over other available insurance coverage; alternatively if the CGL and umbrella, excess of reinsurance states that it is pro-rata, it shall be endorsed to be primary with respect to the Ocean County Library.

1. **Worker's Compensation-** Limits according to Worker's Compensation Laws of the State of New Jersey.
2. Contractors Liability not less than \$100,000.

3. **Comprehensive General Liability** – Bodily Injury \$500,000 per person; \$1,000,000 per occurrence. Property Damage- \$1,000,000 per occurrence.
4. **Comprehensive General Liability shall include the following:**
5. Coverage for explosion, collapse or underground hazards.
6. Occurrence basis coverage.
7. Broad form property damage coverage.
8. Coverage for personal injury sustained by any person as a result of an offense directly or indirectly related to the employment of such person by the insured.
9. **Comprehensive Automobile Liability shall include the following:**
10. Business auto liability insurance or its equivalent with a minimum of \$1,000,000. per accident and including coverage for all of the following:
11. . Liability arising out of the ownership, maintenance or use of any auto.
12. Auto non-ownership and hired car coverage.
13. Worker’s Compensation, Comprehensive General Liability and Comprehensive Automobile Liability arising out of subcontractor’s operations shall be identical as that listed above.
14. Professional Liability – Professional Liability or Errors and Omissions Liability Insurance appropriate to the contractors profession with a minimum of \$1,000,000.
15. The firm(s)/individual(s) if awarded a contract, agree(s) to protect, defend and save harmless the Library against any damage for payment for the use of any patented material process, article or device that may enter into the manufacture, construction or form a part of the work covered by either order or contract, and further agrees to indemnify and save harmless the Library from suits or actions of every nature and description brought against it, for, or on account of injuries or damages received or sustained by any party or parties by, or from any of the acts of the firm(s)/individual(s), their servants or agents.

## **NEW JERSEY BUSINESS REGISTRATION REQUIREMENTS**

Pursuant to N.J.S.A.52:32-44, Ocean County Library (“Contracting Agency”) is prohibited from entering into a contract with an entity unless the bidder/proposer/contractor, and each subcontractor that is required by law to be named in a bid/proposal/contract has a valid New Jersey Business Registration Certificate on file with the Division of Revenue and enterprise services within the Department of the Treasury.

Prior to contract award or authorization, the contractor shall provide the Contracting Agency with its proof of business registration and that of any named subcontractor(s).

Subcontractors named in a bid or other proposal shall provide proof of business registration to the bidder, who in turn, shall provide it to the Contracting Agency prior to the time a contract, purchase order, or other contracting document is awarded or authorized.

During the course of contract performance:

- (1) The contractor shall not enter into a contract with a subcontractor unless the subcontractor first provides the contractor with a valid proof of business registration.
- (2) The contractor shall maintain and submit the Contracting Agency a list of subcontractors and their addresses that may be updated from time to time.
- (3) The contractor and any subcontractor providing goods or performing services under the contract, and each of their affiliates, shall collect and remit to the Director of the Division of Taxation in the Department of the Treasury, the use tax due pursuant to the Sales and Use Tax Act, (N.J.S.A. 54:32B-1 et. seq.) on all sales of tangible personal property delivered into the State. Before final payment is made under the contract, the contractor shall submit to the Contracting Agency a complete and accurate list of all subcontractors used and their addresses.

Pursuant to N.J.S.A. 54:49-4.1, a business organization that fails to provide a copy of a business registration as required, or that provides false business registration information, shall be liable for a penalty of \$25 for each day of violation, not to exceed \$50,000, for each proof of business registration not properly provided under a contract with a contracting agency.

### **SUBMISSION REQUIREMENTS**

All responses to the Request for Qualifications ("RFQ"):

1. Will be opened publicly in the Ocean County Library, Toms River Branch, 101 Washington St., Toms River, New Jersey, Administrative Offices, 2nd floor commencing at 11:00 AM, prevailing time, on December 2, 2020.
2. Must be enclosed in a sealed envelope bearing the name and address of the submitter, the name of this RFQ and the RFQ due date on the outside of the envelope.
3. Sealed Responses which are to be hand delivered the day of the opening must be taken and presented to the Library Purchasing Department prior to or at the time the responses to this RFQ are called for.
4. Sealed Responses to the RFQ which are to be mailed, shall be mailed to the:

5. The Library will not be responsible for late mail deliveries and no responses to this RFQ will be accepted by the Library if received after the time stipulated in this notice.
6. An original and (3) three copies of your response to this RFQ must be submitted for your response to be deemed complete.
7. The Library reserves the right to reject any or all proposals, or to waive any informality in the proposals and to accept any proposal deemed in the best interest of the Library.
8. More than one response from a firm(s)/individual(s) under the same names shall not be considered.

### **SELECTION CRITERIA**

A three (3) person committee consisting of management personnel and library commissioners will review and rank all responses. The selection criteria to be used in awarding a contract for the services described herein, shall include:

1. Qualifications of the individuals who will perform the tasks and the amounts of their respective participation. The Library Commission reserves the right to have a personal interview with the person who will be full time on the account;
2. Experience in providing the professional services requested by the Library Commission and references related thereto including the name of the person at the firm who will be handling the day- to- day matters of the account;
3. Ability to perform the tasks in a timely fashion, including staffing and experience with the subject matter including Library Laws of New Jersey and Confidentiality of Library Records; Intellectual Freedom; Censorship and First Amendment Issues; Filtering; Privacy and Confidentiality; the American Library Association's Library Bill of Rights and Freedom to Read Statement; the U.S.A. Patriot Act; and the Commission;
4. Experience in the construction of library facilities under N.J.A.C.
5. Location (distance) of primary office in relation to the Library Commission's administrative offices.
6. Thoroughness and completeness of the applicant's submittal.
7. Recent, current and projected workload of the individual and firm.
8. Hourly Rates. Cost may not be a factor.

### **AWARD**

The Library Commission shall award a contract to the firm(s)/individual that best meet the needs and interests of the Library Commission.

The Library Commission reserves the right to negotiate the terms and conditions of a contract with the successful firm(s)/ individual to obtain the most cost advantageous services for the Library Commission.

A Purchase order will be issued to the firm(s)/individual or firms for the calendar year 2021.

**GENERAL CONDITIONS**

Starting in January 2007, all business entities are advised of their responsibility to file an annual disclosure statement of political contributions with the New Jersey Election Law Enforcement Commission (ELEC) pursuant to N.J.S.A. 19:44A-20.27 if they receive contracts in excess of \$50,000 from public entities in a calendar year. Business entities are responsible for determining if filing is necessary. The contract shall remain in effect for one year.

**MANDATORY EQUAL EMPLOYMENT OPPORTUNITY LANGUAGE**

**GOODS, PROFESSIONAL SERVICE AND GENERAL SERVICE CONTRACTS**

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable, will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex. The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex.

The contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer advising the labor union or workers' representative of the contractor's commitments under this act and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The CONTRACTOR shall indemnify, protect and save harmless the LIBRARY, its agents, servants and employees from and against any and all suits, claims, losses, demands, or damages of whatever kind or nature arising out of or claimed to arise out of the alleged violation. The CONTRACTOR shall, at its own expense, appear, defend and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the LIBRARY'S grievance procedure, the CONTRACTOR agrees to abide by any decision of the LIBRARY which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the LIBRARY or if the LIBRARY incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the CONTRACTOR shall satisfy and discharge the same at its own expense.

The LIBRARY shall, as soon as practicable after a claim has been made against it, give written notice thereof to the CONTRACTOR along with full and complete particulars of the claim. If any action or administrative proceeding is brought against the LIBRARY or any of its agents, servants and employees, the LIBRARY shall expeditiously forward or have forwarded to the CONTRACTOR every demand, complaint, notice, summons, pleading, or other process received by the LIBRARY or its representatives.

It is expressly agreed and understood that any approval by the LIBRARY of the services provided by the CONTRACTOR pursuant to this contract will not relieve the CONTRACTOR of the obligation to comply with the Act and to defend, indemnify, protect and save harmless the LIBRARY pursuant to this paragraph.

It is further agreed and understood that the LIBRARY assumes no obligation to indemnify or save harmless the CONTRACTOR, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the CONTRACTOR expressly understands and agrees that the provision of this indemnification clause shall in no way limit the CONTRACTOR'S obligations assumed in this Agreement, nor shall they be construed to relieve the CONTRACTOR from any liability, nor preclude the LIBRARY from taking any other actions available to it under any other provisions of this Agreement or otherwise at law.
